



Pottsville Area School District Parent/Student iPad Agreement

All students in grades Kindergarten through 12 at Pottsville Area School District are issued an iPad for their educational use. It is our belief that if reasonable precautions and care are taken in the use of the device, it should not experience physical damage. Each student and parent/guardian is asked to read this form carefully. The parent/guardian and the student should sign at the bottom of this document.

Students will NOT be given an iPad until a signed form has been received.

I/We understand that the device and its accessory equipment (iPad case and charger) are the property of the Pottsville Area School District.
I/We understand that the student, with the support of the parent, is responsible for the daily care and maintenance of the device (this includes various accessories such as the iPad case and charger).
I/We understand and agree to abide by the rules and regulations of the Acceptable Use Policy (can be found on the PASD website). Failure to abide by these policies may result in a loss of access as well as other disciplinary or legal action.
I/We understand that all device damages or the theft/loss of the device must be reported to building administration within 24 hours of an incident and complete the Device Incident Report Form.
I/We understand that the iPad must be in its school-issued case when being transported and at school as a reasonable precaution against damage, theft, or loss.
I/We understand that, unless instructed otherwise by a teacher, all students must have their charged device with them each day for every class.
I/We understand that if the student did not exercise proper care and/or take appropriate precautions, and this behavior resulted in damage to the iPad, the cost of the repair will be the responsibility of the student/parent.
I/We understand that we are responsible for a 2nd damage incident charge of \$99. If technology fee has not been paid, we are responsible for the total cost of the repair.
I/We understand that the charging cable and adapter block are not included with the technology fee. If you lose or misplace one or both, you will be required to purchase a replacement from the school district.
I/We understand that the iPad and its accessory equipment must be returned at the end of the school year or if I no longer attend Pottsville Area School District. If these items are not returned, I/We are responsible for the cost to replace them. Failure to return the items within 48 hours may result in legal action. NOTE: I/We further understand that the <u>original</u> district-issued Apple charging cable and adapter block must be returned and that I/We will be responsible to pay the replacement cost if the original is not returned.
I/We understand that inappropriate use of the iPad will result in the loss of privileges, including losing access to the device.
I/We understand that video or audio recording of anyone without his/her consent is prohibited and will result in the loss of privileges, including losing access to the device.
I/We will not download, install, or use file-sharing programs to access music, video, games, applications, etc. Sending mass email messages to students is not permitted, unless directed by a teacher or administrator.
